# DISCOVERY BENEFIT SELECTIONS

## Trip Cancellation Package

2 Benefit(s) in Total

Virginia & Washington residents must select the Trip Cancellation Package

Includes:

- Coverage **up to 100% of your pre-paid, non-refundable trip cost** if you need to cancel your trip for a covered reason.
- For instance, **if you or your traveling companion become sick with COVID-19 before your departure date**, Trip Cancellation will cover expenses for your unused, not refunded trip cost to a max of \$20,000.00.
- Single Occupancy coverage **up to 100% of trip cost** if your traveling companion cancels or interrupts their trip for a covered reason and you choose to still go but have additional costs.

## Cancel For Any Reason

1 Benefit(s) in Total

Includes:

- **Cancellation of a covered trip for any reason not otherwise covered by the policy, up to 75% (50% in Florida) of nonrefundable trip costs. You must purchase within 15 days of initial trip deposit, insure your full trip cost, and cancel before 48 hours of scheduled departure.** Conditions apply.

Cancel For Any Reason requires purchase of the Trip Cancellation Package. Not available to NY residents.

## Trip Interruption

1 Benefit(s) in Total

Includes:

- Coverage **up to 150% of your pre-paid and non-refundable trip cost** if a portion of a trip is missed, or if you must return home early due to unforeseen circumstances, including illness, injury, or death.
- For instance, **if you or your traveling companion become sick with COVID-19 while traveling**, Trip Interruption will cover expenses like additional flight costs if you aren't cleared to travel home on your original return date.

## Trip Delay Package

2 Benefit(s) in Total

Includes:

- **Up to \$200 per day and \$2,500 per trip** to provide coverage for the costs of meals, local transportation and accommodations when your trip is unexpectedly delayed for covered reasons.
- **Missed Connection** provides **\$1,000 of coverage** which can cover you for the cost of extra transportation to rejoin the trip, additional local expenses, and the cost of missed arrangements.

## Baggage Package

2 Benefit(s) in Total

Includes:

- **Up to \$2,500 for reimbursement** of lost, stolen, or damaged luggage, sporting equipment and personal effects.
- **Baggage Delay** provides **up to \$100 per day or \$500 per trip** to cover the purchase of clothing, toiletries, and other essential items if your luggage is delayed for a specified period of time.

Baggage Package may not be purchased by itself.

## Travel Medical Package

2 Benefit(s) in Total

Indiana residents must select the Travel Medical Package

Includes:

- Coverage **up to \$100,000** for the costs to treat a medical emergency, **including COVID-19**, during a trip.
- **Emergency Medical Transportation & Repatriation of Remains, up to \$500,000**, for the transportation of a traveler to the nearest adequate medical facility or home in the event of a medical emergency during their covered trip.

## FOR NH RESIDENTS ONLY

### Travel Medical Package

2 Benefit(s) in Total

Includes:

- Coverage **up to \$50,000** for the costs to treat a medical emergency, including COVID-19, during a trip.
- **Emergency Medical Transportation & Repatriation of Remains, up to \$1,000,000**, for the transportation of a traveler to the nearest adequate medical facility or home in the event of a medical emergency during their covered trip.

## Pet Travel Package

2 Benefit(s) in Total

Includes:

- **Pet Medical** provides **\$2,000 of coverage for necessary veterinarian expenses if your pet becomes sick or injured while traveling with you.**
- **Pet Return** provides **\$500 of coverage** if you're traveling with your pet, and can't continue due to your sickness or injury, and your pet needs to return home.

Not available to FL residents.

## Rental Vehicle Damage

1 Benefit(s) in Total

Includes:

- **Up to \$35,000 for one rented vehicle per traveling party for theft or damages** due to collision, vandalism, windstorm, fire, hail or flood, or any cause beyond your control while in your possession.

Not available to FL residents.

## Accidental Death & Dismemberment

1 Benefit(s) in Total

Includes:

- **\$100,000, \$250,000, or \$500,000 of coverage** for loss of eyesight or hearing, loss of limbs and death resulting from an accident while traveling. Coverage limit is chosen by you.

## Accidental Death & Dismemberment

1 Benefit(s) in Total

Includes:

- **\$50,000 of coverage** for loss of eyesight or hearing, loss of limbs and death resulting from an accident while traveling.

## Vacation Rental Damage

1 Benefit(s) in Total

Includes:

- Reimbursement for the cost to replace damaged personal property assigned to a rental property during a stay. Coverage is provided to all traveling companions occupying the rental property during the covered trip, provided you are listed on the rental agreement.

Select limits of \$1,500, \$3,000 or \$5,000.
